### LDF CHA By-Laws

#### Article II Board of Commissioners 2.10 General Powers and Numbers

The business and affairs of the Authority shall be managed by its Board of Commissioners in accordance with Lac du Flambeau Tribal Code Chapter 90 ("Housing Authority Ordinance." Hereinafter, "Tribal Ordinance.") The number of Commissioners of the Authority shall be set forth in the Tribal Ordinance establishing the Authority.
